1. Indigenous Peoples of Turtle Island

In the context of Turtle Island, which spans North America encompassing Canada and the United States, Indigenous Peoples and their descendants are recognized as the original inhabitants. This collective term, and less commonly Aboriginal, includes First Nations, Inuk, and Metis communities, each characterized by distinct languages, cultures, and traditions that vary across Nations, language groups, and regions.

Dalhousie recognizes that false claims of Indigeneity are harmful regardless of intent. Such claims produce an erosion of trust, and can result in the misappropriation of resources that are intended to support Indigenous Peoples. Consultations related to the processes by which Indigenous citizenship/community membership may be affirmed are ongoing at the university.
